What is a CrimeWatch/Block club?

A CrimeWatch/Block Club is a self-help cooperative effort to reduce crime and fear of crime. This is achieved by citizens, law enforcement, and local government working together. Members of a Block Club are not asked to be vigilantes or to assume the role of the police. However, they assist law enforcement by observing and reporting suspicious activity.

What do I need to do to start a CrimeWatch/Block Club?

Determine Interest:

1. Talk with your neighbors and get as many as you can to attend a meeting at a location of your choosing.
2. Send me a list of about 2-3 dates that would be good for your meeting.
3. I will attend that meeting and bring materials and tell you and your neighbors in detail what they need to form the group.

3. Hospitality Person

- Welcome new neighbors
- Share Crimewatch information
- Maintain periodic contact with neighbors who has special needs
